ADDITIONAL COMMENTS:

THE SEWAGE SYSTEM INSTALLED SERVICES A 274 SQ. METRE DWELLING WITH 27.5 FIXTURE UNITS AND 5 BEDROOMS. THE SYSTEM CONSISTS OF A 7,000 LITRE CONCRETE SEPTIC TANK AND 2 - 33.4 SQ. METRE FILTER BEDS. THE MAXIMUM DAILY SEWAGE FLOW IS 3.340 LITRES/DAY. NOTE: The land in the vicinity of the sewage system shall be maintained (free of deep rooting vegetation, trees, etc.) in a condition that will not cause damage to, or impair the functioning of, the sewage system.
